# Background

- ICAID  
Industry Connections Activity Initiation Document
- ICCom oversees ICAID authorization
- ICAID are typically approved for two years  
subject to renewal application
- Renewal involves a non-negligible amount of bureaucratic activity
- In 2023, ICCom initiated an autorenewal process.

# LMSC ICAID Issue

- **IEEE 802 LMSC Operations Manual, v26**

- **10. Procedure for ICAIDs**
- **10.1 IEEE-SA standards board approval**

*An industry connections activity is authorized by the IEEE-SA Standards Board upon recommendation by the Industry Connections Committee (ICCom). ICCom requires the IEEE 802 LMSC to approve the Industry Connections Activity Initiation Document (ICAID).*

- **10.2 IEEE 802 LMSC approval**

*A proposed ICAID and supporting documents shall be submitted to the IEEE 802 LMSC via the IEEE 802 LMSC email reflector for review no less than 30 days prior to the day of the opening IEEE 802 LMSC meeting of an IEEE 802 LMSC Plenary Session...*

# ICAID Approval in ICCOM

- IEEE SA Industry Connections Committee Operations Manual, 2023
- *ICCom shall review all Industry Connections Activity Initiation Documents (ICAIDs) for proposed new activities, and requests for revisions to previously approved ICAIDs, and make recommendations to the CAG regarding their approval.*
- *For an IC activity which does not operate under the oversight of an IEEE Standards Committee, ICCom shall serve as the oversight committee of that activity.*
- *ICCom shall review all requests from activity Chairs to terminate their approved IC activities, and shall make recommendations to the CAG regarding the approval of such requests.*
- *In the event that ICCom, without request from the activity Chair, determines that an activity needs to be terminated, ICCom shall take appropriate actions to notify the activity Chair and recommend termination to the CAG.*
- ICAID form instructions:
  - IC activities are chartered for two years at a time. Activities are eligible for extension upon request and review by ICCom and the responsible committee of the IEEE SA Board of Governors.*

## Ambiguity

- Since ICom processes the autorenewal without input, there is no ICAID to be forwarded.
- The LMSC OpsManual says:
  - ICom requires the IEEE 802 LMSC to approve the Industry Connections Activity Initiation Document (ICAID).*
  - Autorenewal is of an ICAID that is LMSC-approved.*
- What's the role of LMSC regarding autorenewal?

# Proposal

- In IEEE 802 LMSC Operations Manual (v26 Revised 17 March, 2023), add at the end of 10.2 (“IEEE 802 LMSC approval”):
- *Notice of intent to revise or withdraw the ICAID shall be submitted to the IEEE 802 LMSC no less than 30 days prior to the day of the opening IEEE 802 LMSC meeting of an IEEE 802 LMSC Plenary Session. An ICAID subject to ICCOM auto-renewal shall not be subject to an IEEE 802 LMSC renewal requirement.*
