Role of the ITU standing committee

ITU SC Objective / Scope

- Receive updates on IEEE SA engagements with ITU
- Do not interfere with existing technical liaisons to ITU-T (e.g., in 802.1, 802.3)
- Do not interfere with existing regulatory liaisons with ITU-R (e.g., in 802.18)

• The subgroup is responsible for assisting the Sponsor (e.g., drafting all or a portion of a document, drafting responses to comments, drafting public statements on standards, or other purely advisory functions).

 - The ITU SC works by consensus (as determined by the chair)
 - Any voting or approvals is done by the LMSC

 - Review proposed positions/contributions, if any
 - IEEE-SA staff or volunteers may propose
 - Formalize volunteer engagement in ITU events
 - Hold conference calls as needed between plenaries


IEEE membership in ITU

IEEE and ITU

- IEEE is a Sector Member of ITU-T, ITU-R and ITU-D
 - Participate in the work of ITU-T Study Groups, Working Parties and expert groups, seminars, round tables, colloquia and workshops
 - Attend ITU and ITU-T decision-making bodies (e.g., ITU Plenipotentiary Conference, World Telecommunication Standardization Assembly)
 - ITU Council granted no fee sector membership ~2002
- IEEE is classified as a "regional or other international organization"
- IEEE is <u>qualified</u> by <u>TSAG</u> as
 - <u>ITU-T A.5</u> Making reference to documents from other organizations.
 - It was also qualified under the now withdrawn
 - <u>ITU-T A.6</u> Cooperation and exchange of information with national and regional SDOs

Register for a TIES Account

- Typically, volunteers get access under their company's membership

 - Reviewing SDO activities


Recent ITU conferences

UN Global Digital Compact

- ITU will continue to engage in the Global Digital Compact (GDC) process.
 - The Global Digital Compact is expected to "outline shared principles for an open, free and secure digital future for all".
- UN Summit of the Future Sept 2024
 - convene world leaders to forge a new international consensus on delivering a better present and safeguarding the future.
 - ITU will support the implementation, similar to WSIS

Standardization impacts

- We commit by, 2030, to:
- (a) Develop, disseminate and maintain, through multi-stakeholder cooperation, safe and secure open-source software, open data, open artificial intelligence models and open standards that benefit society as a whole (SDGs 8, 9 and 10);
- (b) Promote the adoption of open standards and interoperability to facilitate the use of digital public goods across different platforms and systems (all SDGs);

 remain controversial and there is no consensus yet
 - Propose no change at WTSA for A-series

ITU-T WTSA-24





- World Telecommunication Standardization Assembly
 - non-binding, non-treaty
 - usually held every four years WTSA-24 took place in 15-24 October 2024
 - · First time in Asia hosted by India
 - leadership appointment for Study Groups
 - organized in committees to define the next period of study for ITU-T, two substantive :
 - COM3 Working Methods, which will discuss such matters as proposed changes to
 - Resolution 1 (Rules of procedure of ITU-T),
 - · Recommendation A.1 (Working methods for study groups of ITU-T) and
 - COM4 Work Programme and Structure, which will decide on a set of study groups in addition to question definition
 - · Political and thematic topics will also be in scope



ITU-T WTSA-24





- COM4 ITU-T work programme and organization
 - Resolution 2
 - Consolidation of SG9+16 into SG21
 - · Description, lead study groups, points of guidance and question text
 - Updated description for all but two Study Groups (3 & 15)
 - · One question (on network trust in SG13) was not approved
 - Joint collaboration SG 17+ 20 on IoT security, SG 13, 17 + 20 on trust, SG2 + 2- on IoT identification
 - AI resolution apply AI to ICTs
 - Sustainable Digital transformation & Digital public infrastructure resolutions
 - Metaverse resolution interoperability
 - Vehicular communications resolution
 - V2X & ITS ecosystem, collaborate with SDOs (IEEE, ETSI, 3GPP, IETF, ...)
 - Digital identity and PQC in SG17

 - Minor informative addition on marks in A.25
 - Resolution 68 industry engagement
 - · Significant update recognizing industry, creating a working workshop and expanded CTO meetings
 - No change in Resolution 90 open source
 - · Survey use of open source, and develop training
 - New resolutions on engaging next generation & strategic planning
 - Training and encouragement
 - Provide ITU-T input into Council and drive results-based management
 - Resolution 7 ISO/IEC formalize SPCG
 - Resolution 22 TSAG
 - · Monitor chair/vice-chair attendance, reports 30 days in advance
 - Resolution 32 EWM
 - · Real-time webcast for all meetings, mobile friendly web site
 - No agreement to support remote decision making
 - Resolution 74 sector members from developing countries

ITU Council

- The Council acts as the Union's governing body in the interval between Plenipotentiary Conferences.
- Its role is to consider broad telecommunication policy issues to ensure that the Union's activities, policies and strategies fully respond to today's dynamic, rapidly changing telecommunications environment.
- Meets yearly, with two additional working group clusters in between

ITU Council - February 2025

- Council Working Groups, Expert Groups
- Key issues
 - draft Strategic and Financial Plans for 2028-2031
 - · Consultation underway online until Dec 2
 - Preliminary Amount of the Contributory Unit
 - · Increase expected, as well as another review of waivers
 - EG on Decision 482
 - Cost recovery on satellite registrations
 - Remote participation
 - Draft guideline developed by correspondence in line with PP Res 167.
 - But ... remote decision-making is too complex from a legal and practical perspective
 - CWG-LANG is not studying the inclusive languages issue
 - More likely that SCV will review and provide guidance

ITU Council - cont'd

- Alternative reassessed project for ITU's headquarters premises
 - <u>Decision 640</u> confirmed redesign to meet the budget CHF 170 million
 - New building will replace only Varembé
 - 15000 sqm with large conference, cafeteria, lounge and ~20 meeting rooms
- Next steps
 - Swiss government agreement on ITU loan and support for CICG/Palexpo conference venues during construction

- World Summit on the Information Society
 - ITU + UNESCO + UNCTAD + UNDP
 - discuss the role of ICTs to implement the UN Sustainable Development Goals



- ICTs for Well-Being, Inclusion and Resilience: WSIS Cooperation for Accelerating Progress on the SDGs
- 12-week agenda planned with 250+ sessions
 - High level event in person <u>7-11 July, 2025</u>
- Open Consultation process
 - Themes, Topics, Speakers, Workshops, Exhibits
 - IEEE SA is a Specific Activity Partner
 - Includes thematic workshop, HL policy session, HL track facilitator
 - Topic focused on climate change, child online protection, AI ethics
 - Previous IEEE 802 topic Time-Sensitive Networking in 2022

WSIS+20 next steps

- Council endorsed the ongoing WSIS Forum as a global platform facilitating the implementation of WSIS Action Lines as a complement to the UN Sustainable Development Goals.
- ITU remains committed to the WSIS multi-stakeholder community for the upcoming WSIS+20 Review and beyond.
 - promoting inclusive international cooperation to drive sustainable digital development for all.
 - WSIS Stocktaking Database and annual WSIS Prizes contest.

ITU-D WTDC



- World Telecommunication Development
 Conference (WTDC) considers topics, projects
 and programmes relevant to telecommunication
 development.
- WTDC-25 will take place in Baku, Republic of Azerbaijan from 17 to 28 November 2025

 - Dual logo
 - · no process or example

Process

- contribution from a member (e.g., IEEE is a member) to a Study Group proposing the adoption as a new work item
- The level of support to initiate the proposal varies (from 2-4 sector members or administrations) by study group. In SG15 it is 4
- Approval of the NWI is by consensus.
- "Balloting" is using A.8 alternative approval procedure (similar to SA ballot)

802.3 adoption

- ITU-T SG15 Adoption of IEEE Std 802.3
 - Rationale
 - Evolution of long-standing cooperation between 802 and SG15
 - Simplification of process in ITU-T to reference 802.3
 - Parallel to ISO/IEC JTC 1/SC 6 adoption under ISO/IEEE PSDO agreement
 - Continue to pursue ISO/IEC JTC 1/SC 6 adoption as we have in the past
 - Would result in "ITU-T Recommendation G.eth Standard for Ethernet"
 - <u>ITU-T A.5</u> Generic procedures for including references to documents of other organizations in ITU-T Recommendations
 - Incorporation of IEEE Std 802.3 and its amendments by reference
 - Contributions for July 2024 SG15 meeting
 - <u>ITU-T A.1</u> template for new work item (NWI) source IEEE
 - Draft of Y.nnn Standard for Ethernet source IEEE
 - Liaison describing support source IEEE 802.3 WG

- 802.3 approval May 17, EC approval June 4, IEEE SA approval June
- Submission ITU-T SG15 C906

Approval of NWI

- Assigned to Q10, confirmation liaison to 802.3 July 12
- Liaison <u>LS136</u> to LMSC indicating SG15 adoption scope includes all IEEE 802
 - Reply sent (not posted yet)

Development

- Discussion with TSB on formatting
- Contributions possible at March 2025 SG15 plenary
- Initiate liaison from March 2025 IEEE 802 plenary, if necessary

Consent

- March 28, 2025
- AAP possible for April 1

Approval

- May 2025 if no comments
- Later depending on number of additional rounds
- Latest at October 2025 plenary

Next steps

- Future adoption in ITU-T SG15
 - July 2025 potentially propose adoption of 802.1Q
 (as it is also referenced in multiple ITU-T Recs)
 - November 2025 provide update to set of 802.3
 amendments for G.eth

Hosting of ITU-T SG15 plenary

IEEE 802 LMSC - July

- Given ITU new building project, opportunity for IEEE 802 to host or sponsor ITU-T SG15 at future plenary
 - Meeting and/or joint workshop
 - July 2026 in Montreal, or November 2026 in Bangkok next appropriate time
 - Staff request given the collaboration and standards development coordination with ITU-T SG15, confirm that IEEE 802 can host or sponsor an ITU-T SG15 plenary
 - Staff response Sponsorship of the ITU-T SG 15 meeting is permissible in this specific instance, if approved by vote of the IEEE 802 community.

ITU-T SG15 & IEEE 802

- There has been a cordial liaison relationship and mutual participation for decades
- IEEE 802 plenary was hosted in Geneva by ITU in July 2013
 - There was no registration fee and no network fee
 - Facility was ITU HQ building and adjacent CICG convention centre
 - The session was followed by an ITU-T SG15 plenary
- 802.1 & 802.3 interims have been hosted as well
 - May 2007, May 2010, January 2018 and January 2020
- A joint workshop between SG15 and 802 was held on the weekend
 - This event that has been repeated with the <u>ninth</u> edition in July 2024

ITU new building project

- ITU buildings will be closed for hosting meetings from mid-2026 until at least 2028.
 - Revised project to demolish the oldest building (Varembé) and replace
 - Tower will be replaced in a subsequent project to be initiated in the 2030s
- New building opening in early 2031
 - Hosts are invited for all ITU meetings during construction
 - Final approval expected at June 2025 Council
- Given good relationship with ITU-T SG15, the ITU hosting of IEEE 802 sessions, and the alignment of sessions in 2026, IEEE 802 should consider hosting ITU-T SG15 in conjunction with our July 2026 session
 - Sheraton Montreal has space available, and this could be included in 802 contract amendment
 - Network & meeting planning provided by IEEE 802 service providers
 - Workshop hosted by IEEE 802

Proposal July 2026 - Le Sheraton Montreal

- ITU-T SG15 plenary
 - □ July 5 –10
 - Only one week due to hotel availability
- 10th Joint IEEE 802 and ITU-T Study Group 15 Workshop
 - July 11-12 (Saturday + Sunday morning)
- IEEE 802 plenary
 - July 13-17

July 2026 budget

- Not to exceed US\$175,000
- Note July 2024 budget (for 2 weeks without workshop) was US\$250k

• Approve hosting of ITU-T SG15 July 2026 Plenary Session adjacent to IEEE 802 plenary including the hosting of a joint workshop, with cost not to exceed US\$175,000
