- **Release 4.6 - 1 July 2025:**
 - Additional RevCom exports for editorial staff
 - Do not allow submission of PARs with numbers matching existing projects/standards
 - Backend technology upgrades
 - Updates to Amendment PAR purpose field labels and instructional text. (Detail on following slides)
 - Miscellaneous text updates and bug fixes
- **Release 4.5 - 27 March 2025:**
 - "Meets Editorial Requirements" on ballot details changed to allow additional status values: "Under Review", "Meets Editorial Requirements", "Does Not Meet Editorial Requirements"
 - Added an "Assigned Editor" to the ballot details screen. Assigned editor will also be copied on ballot notification emails
 - New P&P submissions will go onto the following AudCom agenda if submitted within 5 days of a meeting
 - Allow AudCom admin to delete submitted P&P files
 - Allow SA Governance staff to correct "Inactive" standards records to "Superseded" if later revisions have been approved.
