# Role of the ITU standing committee

#### ITU SC Scope

- Provide IEEE 802 input into IEEE SA engagements with ITU
- Receive updates on IEEE SA engagements and relevant activities in ITU
- Do not interfere with existing technical liaisons to ITU-T (e.g., in 802.1, 802.3)
- Do not interfere with existing regulatory liaisons with ITU-R (e.g., in 802.18)

• The subgroup is responsible for assisting the Standards Committee (e.g., drafting all or a portion of a document, drafting responses to comments, drafting public statements on standards, or other purely advisory functions).

#### Membership

- Any 802 participant can attend and there are no members
- Policy on reciprocal attendance rights for 802 WGs is per home WG

#### Voting

- The ITU SC works by consensus (as determined by the chair)
- Any voting or approvals is done by the LMSC

#### Duties

- Preparation for upcoming ITU events for IEEE 802 & IEEE SA
- Summarize issues to be discussed per ITU event
- Review proposed positions/contributions/liaisons, if any
  - IEEE-SA staff or IEEE 802 participants may propose
- Formalize volunteer engagement in ITU events, if necessary
- Hold conference calls as needed between plenaries


# IEEE membership in ITU

#### IEEE and ITU

- IEEE is a Sector Member of ITU-T, ITU-R and ITU-D
  - Participate in the work of ITU-T Study Groups, Working Parties and expert groups, seminars, round tables, colloquia and workshops
  - Attend ITU and ITU-T decision-making bodies (e.g., ITU Plenipotentiary Conference, World Telecommunication Standardization Assembly)
  - ITU Council granted no fee sector membership ~2002
- IEEE is classified as a "regional or other international organization"
- IEEE is <u>qualified</u> by <u>TSAG</u> as
  - <u>ITU-T A.5</u> Making reference to documents from other organizations.
  - It was also qualified under the now withdrawn
    - <u>ITU-T A.6</u> Cooperation and exchange of information with national and regional SDOs

#### Register for a TIES Account

- Typically, volunteers get access under their company's membership
- Any IEEE 802 WG member may apply for a TIES Account under IEEE
  - Provides access to ITU-T documents

#### Attendance at ITU

- Typically, volunteers attend under their company's membership
- Volunteer attendance at ITU meetings as an IEEE representative requires IEEE-SA approval

# Key topics included

- Industry engagement
  - ITU industry workshop now yearly because of Resolution 68 update
  - Recognition of the value of industry in strategic plan

#### Working methods

- proposed changes for A.1 (e.g., on support required for new work)
   remain controversial, but joint activities between SGs need definition
- New A.ra for registration authorities to have an ITU version of the ISO process that is followed
- A.supp4 on remote participation will be superseded by Council document
- New A.18 process on review of JCAs

#### Coordination

- AI, trust, numbering result in new JCAs
- Digital transformation
- Meeting efficiency

# Comparison of new work support

- ITU-T
  - 1 member of 192 member states and ~800 sector members
- ISO
  - 5 members of 173 national bodies
- IEC
  - 4 or 5 members of 62 national bodies
- IEEE SA
  - 3 members of ~450 entity members

#### ITU Council

- The Council acts as the Union's governing body in the interval between Plenipotentiary Conferences.
- Its role is to consider broad telecommunication policy issues to ensure that the Union's activities, policies and strategies fully respond to today's dynamic, rapidly changing telecommunications environment.
- Meets yearly, with two additional working group clusters in between

#### ITU Council - June 2025

- Key issues
  - WRC-27 Shanghai
  - draft Strategic and Financial Plans for 2028-2031
  - Preliminary Amount of the Contributory Unit
    - · No fee increase, however another review of waivers
  - Biennial budget
    - Cost recovery on satellite registrations agreed
  - Remote participation
    - · Agreed guideline developed by correspondence PP Res 167 update expected
      - · remote decision-making is too complex from a legal and practical perspective
  - Artificial Intelligence
    - · AI for Good, AI standards summit, AI JCA...
  - CWG-LANG is not studying the inclusive languages issue
    - Perhaps SCV will review and provide guidance

#### ITU Council - cont'd

- Alternative reassessed project for ITU's headquarters premises
  - <u>Decision 640</u> confirmed redesign to meet the budget CHF 170 million
  - New building will replace only Varembé
    - 15000 sqm with large conference, cafeteria, lounge and ~20 meeting rooms
  - Swiss government confirmation on ITU loan
- Next steps
  - Design/execution process agreement, final approval at PP-26
  - Business continuity given CICG renovation
    - Alternative Geneva venues vs member state hosting

#### WSIS+20 Forum 2025

- World Summit on the Information Society
  - ITU + UNESCO + UNCTAD + UNDP
    - discuss the role of ICTs to implement the UN Sustainable Development Goals



- ICTs for Well-Being, Inclusion and Resilience: WSIS Cooperation for Accelerating Progress on the SDGs
- 12-week agenda planned with 250+ sessions
  - High level event in person <u>7-11 July, 2025</u>
- Open Consultation process
  - Themes, Topics, Speakers, Workshops, Exhibits
  - IEEE SA is a Specific Activity Partner
    - Includes thematic workshop, HL policy session, HL track facilitator
    - Topic focused on climate change, child online protection, AI ethics

#### WSIS+20 next steps

- Council endorsed the ongoing WSIS Forum as a global platform facilitating the implementation of WSIS Action Lines as a complement to the UN Sustainable Development Goals.
- ITU remains committed to the WSIS multi-stakeholder community for the upcoming WSIS+20 Review and beyond.
  - promoting inclusive international cooperation to drive sustainable digital development for all.
  - WSIS Stocktaking Database and annual WSIS Prizes contest.

# Incorporation by Reference (IBR) of IEEE 802 standards by ITU-T

#### IBR at ITU-T

- Options for adoption/IBR -- ordered from simplest to most complex :
  - A.5 referencing
    - example https://www.itu.int/rec/T-REC-Z.161-202210-I
  - A.25 incorporation
    - example https://www.itu.int/rec/T-REC-Y.4500.1-201801-I
  - A.23 twinned (with ISO/IEC JTC1)
    - example <a href="https://www.itu.int/rec/T-REC-H.265-202108-S">https://www.itu.int/rec/T-REC-H.265-202108-S</a>
  - Dual logo
    - no process or example

#### Process

- contribution from a member (e.g., IEEE is a member) to a Study Group proposing the adoption as a new work item
- The level of support to initiate the proposal varies (from 2-4 sector members or administrations) by study group. In SG15 it is 4 from 2 countries
- Approval of the NWI is by consensus.
- "Balloting" is using A.8 alternative approval procedure (similar to SA ballot)

## 802.3 adoption

- ITU-T SG15 Adoption of IEEE Std 802.3
  - Rationale
    - Evolution of long-standing cooperation between 802 and SG15
    - Simplification of process in ITU-T to reference 802.3
  - Parallel to ISO/IEC JTC 1/SC 6 adoption under ISO/IEEE PSDO agreement
    - Continue to pursue ISO/IEC JTC 1/SC 6 adoption as we have in the past
  - Would result in "ITU-T Recommendation G.eth Standard for Ethernet"
    - <u>ITU-T A.5</u> Generic procedures for including references to documents of other organizations in ITU-T Recommendations
    - Incorporation of IEEE Std 802.3 and its amendments by reference
  - Contributions for July 2024 SG15 meeting
    - ITU-T A.1 template for new work item (NWI) source IEEE
    - Draft of Y.nnn Standard for Ethernet source IEEE
    - Liaison describing support source IEEE 802.3 WG

- 802.3 approval May 17, EC approval June 4, IEEE SA approval June
- Submission ITU-T SG15 C906

#### Approval of NWI

- Assigned to Q10, confirmation liaison to 802.3 July 12, 2024
- Liaison <u>LS136</u> to LMSC indicating SG15 adoption scope includes all IEEE 802
  - Reply posted as LS3

#### Development

- Draft G.eth TD66
- Contributions <u>C250</u> & <u>C364</u> (on referencing conventions) at March 2025 SG15 plenary
- Initiate liaison from March 2025 IEEE 802 plenary, if necessary

#### Consent

- March 28, 2025
- AAP April 15 comments received

#### Approval

- Management team along with TSB handled the comment
- August 2025 approval

# Next steps

- Maintenance
  - Contribution required future new work items
  - Liaison sufficient for updates to in-force Recommendations
    - Respond to liaison EC-25-102
- Promotion
  - Social media, blog post, White paper
- Future IBR in ITU-T SG15
  - September 2025 provide update to set of 802.3 amendments for G.8020.3
  - November 2025 propose IBR of 802.1Q (as it is also referenced in multiple ITU-T Recs) and potentially 802.11-2024

# IEEE 802 LMSC - July 2026

- Given ITU new building project, opportunity for IEEE 802 to host or sponsor ITU-T SG15 at future plenary
  - Meeting and/or joint workshop
    - July 2026 in Montreal, or November 2026 in Bangkok next appropriate time
  - Staff request given the collaboration and standards development coordination with ITU-T SG15, confirm that IEEE 802 can host or sponsor an ITU-T SG15 plenary
  - Staff response Sponsorship of the ITU-T SG 15 meeting is permissible in this specific instance, if approved by vote of the IEEE 802 community.

#### ITU-T SG15 & IEEE 802

- There has been a cordial liaison relationship and mutual participation for decades
- IEEE 802 plenary was hosted in Geneva by ITU in July 2013
  - There was no registration fee and no network fee
  - Facility was ITU HQ building and adjacent CICG convention centre
  - The session was followed by an ITU-T SG15 plenary
- 802.1 & 802.3 interims have been hosted as well
  - May 2007, May 2010, January 2018 and January 2020
- A joint workshop between SG15 and 802 was held on the weekend
  - This event that has been repeated with the <u>ninth</u> edition in July 2024

## July 2026 - Le Sheraton Montreal

- ITU-T SG15 plenary June 29 July 10
  - June 29 July 3 at McGill University
  - July 5-10 at Sheraton (due to availability)
- 10<sup>th</sup> Joint IEEE 802 and ITU-T Study Group 15 Workshop
  - July 11-12 (Saturday + Sunday morning)
- IEEE 802 plenary
  - July 13-17
- Budget approved (Nov 2024) not to exceed US\$175,000

#### IEEE 802 LMSC summary

- Future IBR in ITU-T SG15
  - Liaison response motion
    - · use liaisons for maintenance, joint promotion, workshop
  - Wait until approval of G.8020.3 (expected in August)
     before 802.1 (or potentially other 802 WG) propose a
     new recommendation with incorporation by reference
- July 2026 hosting of ITU-T SG15 before IEEE 802 plenary including workshop
  - Planning initiated for joint workshop
  - Visa request process
