## About IEEE 802 Network Enhancements for the Next Decade Industry Connections (IC) Program

The mobile industry is currently pursuing the development of the next generation mobile communication networks fulfilling the requirements for extreme mobile broadband, massive machine-type communication, and ultra-reliable and low latency communications as specified in ITU-R M.2083 for IMT-2020.

IEEE 802 technologies are mainly deployed in communication infrastructures outside of the IMT domain. Therefore, to address emerging network requirements, the IEEE 802 LAN/MAN Standards Committee is launching a new initiative under the **IEEE Standards Association (IEEE-SA) Industry Connections Program**. This activity will assess emerging requirements for IEEE 802 based communication infrastructures, identify commonalities, gaps, and trends not currently addressed by IEEE 802 standards and projects, and facilitate building industry consensus towards proposals to initiate new standards development efforts. # Guidelines for IEEE-SA Meetings

- ▣ **All IEEE-SA standards meetings shall be conducted in compliance with all applicable laws, including antitrust and competition laws.**
- ▣ **Don't discuss the interpretation, validity, or essentiality of patents/patent claims.**
- ▣ **Don't discuss specific license rates, terms, or conditions.**
  - ▣ Relative costs, including licensing costs of essential patent claims, of different technical approaches may be discussed in standards development meetings.
    - ▣ Technical considerations remain primary focus
- ▣ **Don't discuss or engage in the fixing of product prices, allocation of customers, or division of sales markets.**
- ▣ **Don't discuss the status or substance of ongoing or threatened litigation.**
- ▣ **Don't be silent if inappropriate topics are discussed... do formally object.**

# Participation in IEEE 802 Meetings

**Participation in any IEEE 802 meeting (Sponsor, Sponsor subgroup, Working Group, Working Group subgroup, etc.) is on an individual basis**

- **Participants in the IEEE standards development individual process shall act based on their qualifications and experience. ([https://standards.ieee.org/develop/policies/bylaws/sb\\_bylaws.pdf](https://standards.ieee.org/develop/policies/bylaws/sb_bylaws.pdf) section 5.2.1)**
- **IEEE 802 Working Group membership is by individual; “Working Group members shall participate in the consensus process in a manner consistent with their professional expert opinion as individuals, and not as organizational representatives”. (subclause 4.2.1 “Establishment”, of the IEEE 802 LMSC Working Group Policies and Procedures)**
- **Participants have an obligation to act and vote as an individual and not under the direction of any other individual or group. A Participant’s obligation to act and vote as an individual applies in all cases, regardless of any external commitments, agreements, contracts, or orders.**
- **Participants shall not direct the actions or votes of any other member of an IEEE 802 Working Group or retaliate against any other member for their actions or votes within IEEE 802 Working Group meetings, see [https://standards.ieee.org/develop/policies/bylaws/sb\\_bylaws.pdf](https://standards.ieee.org/develop/policies/bylaws/sb_bylaws.pdf) section 5.2.1.3 and the IEEE 802 LMSC Working Group Policies and Procedures, subclause 3.4.1 “Chair”, list item x.**

**By participating in IEEE 802 meetings, you accept these requirements. If you do not agree to these policies then you shall not participate.**

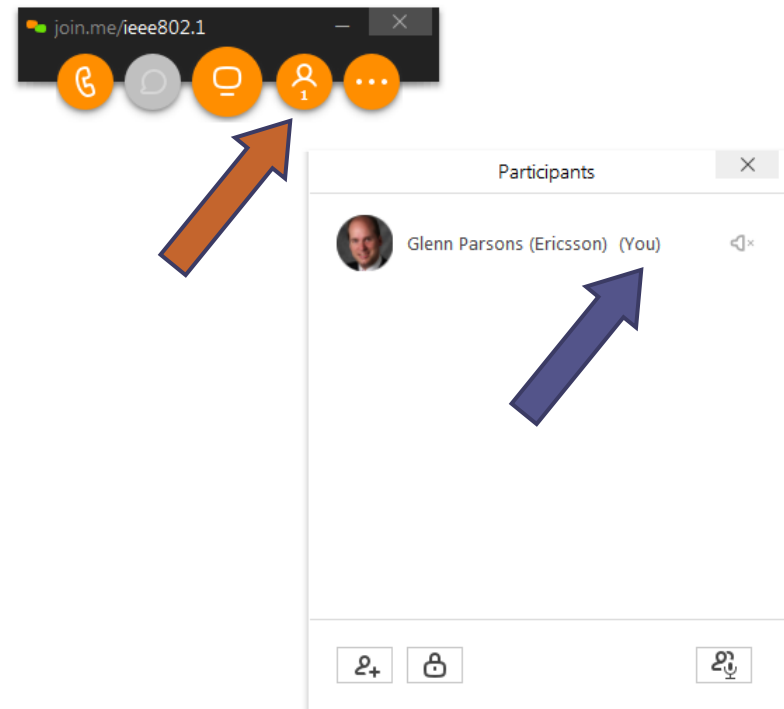

# 802 NEND Objective

- The goal of this activity is to assess, outside of the IMT activity, emerging requirements for IEEE 802 wireless and higher-layer communication infrastructures, identify commonalities, gaps, and trends not currently addressed by IEEE 802 standards and projects, and facilitate building industry consensus towards proposals to initiate new standards development efforts.
- Encouraged topics include enhancements of IEEE 802 communication networks and vertical networks as well as enhanced cooperative functionality among existing IEEE standards in support of network integration. Findings related to existing IEEE 802 standards and projects are forwarded to the responsible working groups for further considerations.

# Operating practice

- Voting
  - While operating as a subgroup under IEEE 802.1, any person attending a meeting may vote on all motions (including recommending approval of the deliverables). A vote is carried by 75% of those present and voting Approve or Disapprove.
- Reciprocal attendance rights for 802 WGs
  - policy is per home WG
- Approval
  - Until March 2019

# Potential Markets

- IEEE 802 technologies are deployed in a huge number of market applications, which are exhibiting a growing diversity in terms of the features needed. Solutions spanning these different application spaces and feature requirements will be best addressed by leveraging common technology approaches. This activity will enable industry consensus building on the market/application requirements and identify gaps and trends not currently addressed by IEEE 802 standardization of new solutions, which will help to foster industry engagements in new study groups and standardization topics.

# Deliverable

- There will be two deliverables:
  - Records of the meetings, including minutes and supporting presentations.
  - A report documenting the findings of the IC activity, with recommendations regarding new standardization topics, documentation of use cases and user needs for those topics, and proposed organizational approaches to ensure effective participation from user communities. It is expected that the first draft of the report documenting the findings of the IC will be available in March 2018.
- Related work
  - The proposed activity addresses topics distinct from the IEEE 802.3 'New Ethernet Applications' Industry Connections activity. It will cooperate when findings may benefit both activities.
