MINUTES

October 25, 2012

Chair: Xiaoming Peng (I2R)

Chair reviewed IEEE patent policy, no LOA request.

Chair gentally reminded to use the IEEE doc template for document submission, and email the sceratary Peng HAO for the attendance.

Jiamin CHEN (Huawei) reviewed the 11aj usage model.

• New Contribution: 11-12-1245-00 IEEE 802.11aj Usage Models Document

In the document, Category 8 and 9 are included, as follows,

- Category 8: portable device application
 - Usage model 8a: Peer-to-Peer Communication Between Portable Devices.
 - Usage model 8b: Rapid Download Mass Data from Fixed Devices.
 - Usage model 8c: Cloud Computing/Storage & Mass Data Synchronization.
 - Usage model 8d: Wireless Peripheral Application
- Catergory 9: Wireless Networking
 - Usage model 9a: Access to Internet/Interanet via 60GHz/45GHz MM-Wave AP.

Comments

- Eldad (Intel) suggested highlighting the new usage model part should be highlighted in the document. He explained that Category 1-6 worked for both very high throughput (VHT) for 11ac on 5GHz and 11ad on 60GHz. He suggested the usal model document should not include technique content such as 1.08GHz channel bandwidth. The technical content can be included in the later technical proposals.
- Xiaoming and Eldad confirmed that 802.11aj PAR does not consisit of information of 1.08GHz bandwidth. Therefore, it is advised not putting the bandwidth information in the usage model document. However, the data rate, range and power consumption can be mentioned in the usage model.
- Bo Sun (ZTE) commented Usage model 8b, 8c and 8d may have similar issues for both 60GHz and 45GHz. He suggested think of some new usage models for the scenario using narrow bandwidth, e.g. lower power.
- KB (I2R) clarified if usage models for 11ad should be supported by 11aj as well. Eldad explained that 11ad did not have separate usage model document, it used the usage model document from WFA. Both Xiaoming and Eldad confirmed that according to the backward compatibility with 11ad mentioned in 11aj, usage models for 11ad should be supported by 11aj.
- Jiaming highlighted that Usage model 8 and 9 are for portable devices.
- Xiaoming suggested Jiamin modify the usage model document based on the comments and feedback and present in Nov meeting.
