


Figure 20—Successful data transmission without an acknowledgment

- Comment 33: Figure 20 has the title of "Successful data transmission without an acknowledgment", but the actual figure has AR=1, and shows an acknowledgement. I believe the wrong figure is here
- Comment 58: Text is about "without ACK". Buth the figure 20 describes about with ACK




Figure 21—Successful data transmission with an acknowledgment

- Comment 59: In "without ACK" case, AR should be "0". But AR=1 in figure 21.

#### Suggested Remedy

- Comment 33: Put in the correct figure
- Comment 58: Change figure 20 with figure 21
- Comment 59: Change "AR=1" to "AR=0" in figure 21

The message sequence chart in Figure 20 shows the scenario for transmitting a single frame of data from an originator to a recipient without requiring an acknowledgment.

      - In this case, the originator transmits the data frame with the Acknowledgment Request (AR) subfield of the frame control field equal to zero.
