During discussion it was suggested to consider also the obvious missing lower rates (upper right corner of Table). Conclusion: will discuss in January and either include in scope or explain why we should not include it.

SUN-OQPSK: Suggested to include definition of channelization for use of the narrow band (100 kcps) SUN-OQPSK PHY modes in other regions, e.g. North America. Unanimous consensus that this is a good idea and should be included.
