Minutes of the IEEE 802.15.4Cor2 virtual interim Sep meeting

These are the Minutes of the IEEE 15.4Cor2 Interim meeting

Tuesday, 15 Sep, 2020, PM3

Kunal Shah (Acting Chair) called the meeting to order at 3:33 PM PDT.

Reviewed the opening report/ Agenda, doc# 272rev00

Went through meeting, patent, and other IEEE guidelines.

And called for potential essential patents, *nothing heard*.

The following motion was made:

Acting Chair goes through the agenda for the session and asks for any addition to be made to the agenda.

None heard.

Acting Chair asks for any objections approving the agenda. None heard.

Acting Chair mentions that during the opening 15.4 interim meeting the WG Vice Chair has announced Kunal Shah as a temporary Chair for the TG4Cor2.

Kunal asks the TGCor2 members for any objection for Kunal Shah to Chair the task group Cor2.

No objections heard.

Chair goes through the 15.4Cor2 PAR document that was approved by the WG during the July Plenary and planned to be approved by RevCom on the next week call.

Chair asks for any questions/ comments on the PAR document.

There is a comment that is the PAR scope is limited to only the current technical error being found in the Standard or if there any any other technical errors can also be corrected.

Chair responds that the any technical errors found in the Standard is within the scope of this TG PAR. However, if the significant change is to be made to the Standard, then that would require to consider as a new amendment to the Standard.

Chair goes through the document# 171-00 and present the technical error and proposed resolution

There is a comment that the proposed resolution does look fine; however, can there be additional resolution be added to this error.

Chair asks the member to submit the proposal as part of the call for proposals for any proposal to the technical errors.

Chair asks for any other technical error that the member wish to discuss with the group.

There is a discussion about the note in 7.4.1 of 802.15.4-2020, which seem to be confusion and not correct.

The current note states, "A header termination IE is required prior to the payload IEs because the address space of payload IEs and header IEs is not distinct."

Ben mentions that, the address space (ID value space) for header IEs and payload IEs is distinct, separated by the value of the "Type" field in the IE descriptor (0=header, 1=payload).

Ben proposes to remove the NOTE paragraph from the Standard.

There is a comment that the current note in the section is correct and might require some additional updates to make it clear; however, it should not be removed.

Tero took an action to come up with a proposal to respond to the comment.

Chair goes through the next steps and mentions to send out call for proposals for any additional changes required to the errors to the Standard and would give at least 30 days to respond.

The proposals will be discussed during the Nov plenary session.

Chair explains the plan for the Nov meeting.

Chair goes through the closing report, which will be presented at the closing plenary.

Chair asks for any other business.

None heard.

Chair asks for any objections to adjourn the meeting.

None heard.
