It seems that no limitation is applied to the bands between 19.7 and 21.2 GHz!

5.523B The use of the band 19.3-19.6 GHz (Earth-to-space) by the fixed-satellite service is limited to feeder links for non-geostationary-satellite systems in the mobile-satellite service. Such use is subject to the application of the provisions of No. **9.11A**, and No. **22.2** does not apply.

5.523C No. **22.2** shall continue to apply in the bands 19.3-19.6 GHz and 29.1-29.4 GHz, between feeder links of non-geostationary mobile-satellite service networks and those fixed-satellite service networks for which complete Appendix **4** coordination information, or notification information, is considered as having been received by the Bureau prior to 18 November 1995. (WRC-97)

5.523D The use of the band 19.3-19.7 GHz (space-to-Earth) by geostationary fixed-satellite service systems and by feeder links for non-geostationary-satellite systems in the mobile-satellite service is subject to the application of the provisions of No. **9.11A**, but not subject to the provisions of No. **22.2**. The use of this band for other non-geostationary fixed-satellite service systems, or for the cases indicated in Nos. **5.523C** and **5.523E**, is not subject to the provisions of No. **9.11A** and shall continue to be subject to Articles **9** (except No. **9.11A**) and **11** procedures, and to the provisions of No. **22.2**. (WRC-97)

5.523E No. **22.2** shall continue to apply in the bands 19.6-19.7 GHz and 29.4-29.5 GHz, between feeder links of non-geostationary mobile-satellite service networks and those fixed-satellite service networks for which complete Appendix **4** coordination information, or notification information, is considered as having been received by the Bureau by 21 November 1997. (WRC-97)

5.524 Additional allocation: in Afghanistan, Algeria, Saudi Arabia, Bahrain, Brunei Darussalam, Cameroon, China, Congo (Rep. of the), Costa Rica, Egypt, the United Arab Emirates, Gabon, Guatemala, Guinea, India, Iran (Islamic Republic of), Iraq, Israel, Japan, Jordan, Kuwait, Lebanon, Malaysia, Mali, Morocco, Mauritania, Nepal, Nigeria, Oman, Pakistan, the Philippines, Qatar, the Syrian Arab Republic, the Dem. Rep. of the Congo, the Dem. People's Rep. of Korea, Singapore, Somalia, Sudan, South Sudan, Chad, Togo and Tunisia, the frequency band **19.7-21.2 GHz** is also allocated to the fixed and mobile services on a primary basis. This additional use **shall not impose any limitation** on the **power fluxdensity of space stations in the fixed-satellite service** in the frequency band 19.7-21.2 GHz and of space stations in the mobile-satellite service in the frequency band 19.7-20.2 GHz where the allocation to the mobile-satellite service is on a primary basis in the latter frequency band. Section V – Limits of power flux-density from space stations 21.16 § 6 1)

The power flux-density at the Earth's surface produced by emissions from a space station, including emissions from a reflecting satellite, for all conditions and for all methods of modulation, shall not exceed the limit given in Table **21-4**. The limit relates to the power flux-density which would be obtained under assumed free-space propagation conditions and applies to emissions by a space station of the service indicated where the frequency bands are shared with equal rights with the fixed or mobile service, unless otherwise stated.
